

**CITY OF DELTA**

**BYLAW NO. 8425**

*A Bylaw to amend the “Delta Business Licence Bylaw No. 7670, 2017”*

---

The Council of the City of Delta in open meeting assembled, ENACTS AS FOLLOWS:

1. This Bylaw may be cited for all purposes as **“Delta Business Licence Bylaw No. 7670, 2017 Amendment (Mobile Food and Beverage Vendor) Bylaw No. 8425, 2025”**.
2. “Delta Business Licence Bylaw No. 7670, 2017 Amendment”, as amended, is hereby further amended by:

(a) adding the following terms and definitions to part 4, section 4.1:

**Mobile Food and Beverage Vending Permit** means a permit issued by the City of Delta that allows a Mobile Food and Beverage Vendor to prepare and sell certain foods and/or beverages from approved public locations during approved times to the general public for immediate consumption from their Mobile Food and Beverage Vending Unit, all in accordance with the Mobile Food and Beverage Vendor Policy.

**Mobile Food and Beverage Vendor Policy** means the City of Delta’s Mobile Food and Beverage Vendor Policy.

(b) replacing the term “Portable Food Vending Cart” and definition in part 4, section 4.1 with:

**Mobile Food and Beverage Vending Unit** means a truck, trailer, cart, other conveyance, or thing that is permitted to be used for selling certain foods and/or beverages to the general public for immediate consumption, all in accordance with the Mobile Food and Beverage Vendor Policy.

(c) replacing all references to “Portable Food Vending Cart” with “Mobile Food and Beverage Vending Unit”;

(d) replacing the term “Portable Food Vendor” and definition in part 4, section 4.1 with:

**Mobile Food and Beverage Vendor** means a person who sells certain foods and/or beverages to the general public for immediate consumption from a Mobile Food and Beverage Vending Unit.

- (e) replacing all references to “Portable Food Vendor” with “Mobile Food and Beverage Vendor”;
- (f) adding the words “if the unit is a cart” at the end of section 6.47 (a) i. so it reads:  
6.47 (a) i. does not exceed four square metres in area if the unit is a cart;
- (g) adding “and the electrical requirement has been approved by the City” to the end of section 6.47 (a) iii. so it reads:  
6.47 (a) iii. is fully self-contained with no service connection, other than electrical service, provided the Portable Food Vending Cart is located no more than two metres from the point of electrical connection, and the electrical requirement has been approved by the City.
- (h) deleting the words “is located on private property so as not to” from section 6.47 (a) iv. and adding the words “does not” so it reads:  
6.47 (a) iv. does not interfere with or block any exit or walkway;
- (i) deleting section 6.47 (a) vii.;
- (j) revising section 6.47 (c) so it reads:  
6.47 (c) provide written permission from the property owner to the Licence Inspector for the use of the property if operating a Mobile Food and Beverage Vendor Business on private property;
- (k) adding sections 6.47 (e) and (f):  
6.47 (e) only park an unattached trailer that is used as a Mobile Food and Beverage Vending Unit in public locations in accordance with the Mobile Food and Beverage Vendor Policy and this bylaw; and  
  
6.47 (f) obtain a Mobile Food and Beverage Vending Permit if intending to operate in public locations. This permit is subject to the fees outlined in the Consolidated Fees Bylaw.
