## **CITY OF DELTA**

## **BYLAW NO. 8477**

A Bylaw to close certain portions of a public highway and remove their dedication as highway

WHEREAS pursuant to Section 40 of the *Community Charter*, S.B.C. 2003, c. 26 as amended, the Council of the City of Delta may close all or part of a highway that is vested in the municipality to traffic and remove the dedication of a highway that has been or is being closed;

"Highway" is defined under the Community Charter to include a street, road, lane, bridge, viaduct and any other way open to public use, other than a private right of way on private property; and

As required by the *Community Charter*, the Council of the City of Delta posted and published notice of its intention to close the portion of highway referred to in this Bylaw and to remove its dedication as highway and Council provided an opportunity for persons who consider they are affected to make presentations to Council.

NOW THEREFORE the Council of the City of Delta, in open meeting assembled, ENACTS AS FOLLOWS:

- 1. This Bylaw may be cited for all purposes as "Delta Road Closure and Cancellation (LU009735) Bylaw No. 8477, 2025".
- 2. That portion of road outlined in bold and labelled "Road To Be Closed" on Reference Plan EPP128656 prepared by Connor R. Embleton, Watson & Bernard Land Surveyors dated January 17, 2025, a reduced copy of which is attached hereto as Schedule "A" (the "Closed Road"), is hereby stopped up and closed to all traffic.
- 3. The dedication of the Closed Road is hereby removed and cancelled, effective upon filing of this Bylaw in the appropriate Land Title Office and title to the Closed Road shall be vested in the City of Delta.
- 4. The Mayor and City Clerk of the City of Delta are hereby authorized to execute such agreements, advertisement, plans and other documents as required to give effect to the foregoing.
