BYLAW NO. 8415

A Bylaw to amend the "The Corporation of Delta Highways Bylaw No. 6922, 2011"

The Council of the City of Delta in open meeting assembled, ENACTS AS FOLLOWS:

1. This Bylaw may be cited for all purposes as the **"City of Delta Highways Bylaw No. 6922, 2011 Amendment (Mobile Food and Beverage Vendor) Bylaw No. 8415, 2025"**.
2. "The Corporation of Delta Highways Bylaw No. 6922, 2011", as amended, is hereby further amended by:
 - (a) deleting the words "The Corporation of Delta" and replacing them with the words "the City of Delta";
 - (b) adding the following terms and definitions to section 2.1

Mobile Food and Beverage Vending Permit means a permit issued by the City of Delta that allows a Mobile Food and Beverage Vendor to prepare and sell certain foods and/or beverages from approved public locations during approved times to the general public for immediate consumption from their Mobile Food and Beverage Vending Unit, all in accordance with the Mobile Food and Beverage Vendor Policy.

Mobile Food and Beverage Vending Unit means a truck, trailer, cart, other conveyance, or thing that is permitted to be used for selling certain foods and/or beverages to the general public for immediate consumption, all in accordance with the Mobile Food and Beverage Vendor Policy.

Mobile Food and Beverage Vendor means a person who sells certain foods and/or beverages to the general public for immediate consumption from a Mobile Food and Beverage Vending Unit.

Mobile Food and Beverage Vendor Policy means the City of Delta's Mobile Food and Beverage Vendor Policy.

- (c) adding “unless authorized by a Mobile Food and Beverage Vending Permit” to the end of section 6.4 (i) iv. so it reads:

6.4 (i) iv. selling flowers, fruit, vegetables, seafood, produce, or other commodities or articles, unless authorized by a Mobile Food and Beverage Vending Permit;

- (d) adding section 6.5 which reads:

6.5 A Mobile Food and Beverage Vendor may Park on an approved Highway location to prepare and sell food or beverages to the general public for immediate consumption from their Mobile Food and Beverage Vending Unit if they possess a valid Mobile Food and Beverage Vending Permit and follow the requirements of the Mobile Food and Beverage Vendor Policy.

- (e) adding “Unless as authorized by a Mobile Food and Beverage Vending Permit” to section 6.7 (formerly 6.6) so it reads:

6.7 Unless as authorized by a Mobile Food and Beverage Vending Permit, a person must not Park on a Highway an Unattached Trailer that is:

- i. licensed as a commercial Trailer;
- ii. licensed as other than a commercial Trailer; or
- iii. unlicensed.

- (f) adding “Unless as authorized by a Mobile Food and Beverage Vending Permit” to section 6.7.1 (formerly 6.6.1) so it reads:

6.7.1 “Unless as authorized by a Mobile Food and Beverage Vending Permit, no person shall park a Commercial Vehicle or combination of vehicles, between the hours of 7:00 p.m. and 7:00 a.m. of the following day on any Highway.
