BYLAW NO. 8537

*A Bylaw to amend user rates, conditions and terms under or upon
Which water may be supplied and used in the several areas of the
City of Delta referred under Bylaw No. 7441*

WHEREAS the Council may, by Bylaw, fix the rates and terms under which water may be supplied and used and may provide for the classification of users and prescribe different rates, terms and conditions for different users:

NOW THEREFORE, the Council of City of Delta in an open meeting assembled, hereby enacts as follows:

1. This Bylaw may be cited for all purposes as **“Delta Water Service Bylaw No. 7441, 2016 Amendment Bylaw No. 8537, 2025”**.
2. “Delta Water Service Bylaw No. 7441, 2016” as amended is hereby further amended as follows:
 - I. by deleting Schedules “A”(1), “A”(2) and “A”(3), and replacing them with Schedules “A”(1), “A”(2) and “A”(3), respectively attached hereto as Schedules 8537-1, 8537-2, 8537-3, and forming part of this Bylaw.
 - II. by deleting Schedule “B” and replacing it with Schedule “B” attached hereto as Schedule 8537-4 and forming part of this Bylaw.
 - III. by deleting Schedule “C” and replacing it with Schedule “C” attached hereto as Schedule 8537-5 and forming part of this Bylaw.
