Pickleball creates a loud repetitive and continuous sound which will negatively impact our quality of life whether we are working outside, dining on our patio, walking our dog or enjoying the park which has always been a family park. We request that the city remove the four pickleball courts from the “Annieville Lions Park Master Plan” and proceed to find a more appropriate remote location or provide an indoor facility.
