▪ **BACKGROUND:**

At the December 8, 2025 Regular Meeting, Council provided first, second and third readings to Parks Regulation Bylaw No. 8544, 2025, Municipal Ticketing Information Bylaw No. 6639, 2007 Amendment Bylaw No. 8545, 2025, and Delta Bylaw Notice Enforcement Bylaw No. 7009, 2011 Amendment Bylaw No. 8546, 2025.

Parks Regulation Bylaw No. 8544, 2025 is a bylaw to regulate, govern and manage the operation and use of parks and community facilities in the Municipality of Delta.

Updates to the enforcement schedules contained in the Municipal Ticketing Information Bylaw, and the Delta Bylaw Notice Enforcement Bylaw, are required to support and enforce the Parks Regulation Bylaw and allow staff to issue notices and write tickets.
