

**CITY OF DELTA**  
**BYLAW NO. 8545**

*A Bylaw to amend the “Municipal Ticketing Information Bylaw, 6639, 2007”*

The Council of the City Delta in open meeting assembled, ENACTS AS FOLLOWS:

1. This bylaw may be cited for all purpose as **“Municipal Ticketing Information Bylaw No. 6639, 2007 Amendment Bylaw No. 8545, 2025”**.
2. “Municipal Ticketing Information Bylaw No. 6639, 2007, as amended, is hereby further amended by deleting Delta Parks Regulation Bylaw No. 7206, 2013, in its entirety and replacing it with the following:

5.1 (13)	Bring a bike, e-bike, or scooter into a building or structure	500
5.1 (14)	Abandon or moor vessel longer than 3 hours	500
5.2 (1)	Non-permitted consumption of liquor	500
5.2 (2)	Non-permitted use of amplifying system	500

5.2 (3)	Non-permitted use upon body of water	500
6.3	Non-permitted entry of park or municipal land between dusk until dawn	500
7.2	Obstruct a Bylaw Enforcement Officer or person in charge	1000
7.3	Fail to state correct name and address to Bylaw Enforcement Officer or person in charge	500
